HOW TO TURN DOCUMENT 2 INTO A FILLABLE PDF

Option A: Adobe Acrobat (Most Common)

- 1. Save Document 2 as a Word file**
- 2. Open in Adobe Acrobat Pro**
- 3. Select Prepare Form**
- 4. Add:**
 - **6 required checkbox fields**
 - **Text fields for names**
 - **Signature fields (exhibitor + parent)**
 - **Date fields (auto-date enabled)**
- 5. Set all fields to Required**
- 6. Save as PDF**

Rules Checkboxes

- Keep your existing required checkboxes

Signature Fields

- Parent/Guardian Signature (required)
- Date (auto-fill recommended)

Validation Settings

- ✓ Require at least one exhibitor name field to be filled
- ✓ Allow submission even if not all exhibitor fields are used
- ✓ Lock after submission
